Warning! By the nature of the activities, Gymnastics, Cheer, Tumbling, Trampoline, all carry with it the risk of physical injury. No matter how careful the participants and instructors are, no matter how many spotters are used, no matter what height is used, no matter what safety equipment is worn or used or what landing surface exists, risk cannot be eliminated. Risk can be reduced but never eliminated. The risk of injury includes minor injuries such as bruises and more serious injuries such as broken bones, discolorations and muscle pulls. The risk also includes catastrophic injuries such as permanent paralysis or even death from landings or falls on the back, neck or head.

I also expressly grant Sanford Academy or any approved third party of Sanford Academy, the right to film, videotape, photograph, or record my child. I give Sanford Academy irrevocable right to use, display, digitally enhance and/or alter in any manner the film, videotape, photograph, or record of my child and use in any promotional activities to include but not limited to broadcast, television, cable, radio, motion picture, videotape, website, DVD, CD, or any published articles.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK; AND INDEMNITY AGREEMENT
